



# The People's Declaration on HIV and AIDS

The Political Declaration on HIV and AIDS negotiated by Member States of the UN during the 2026 High Level Meeting on HIV and AIDS fails to respond with the ambition, human rights, and solidarity called for by the unprecedented emergency people living with and most affected by HIV are facing around the world.

Compared with the Political Declaration adopted during the 2021 High Level Meeting, Member States' commitments are weaker and less ambitious. Instead of a laser focus on communities most in need—key populations (LGBTQI+ people, sex workers, people who use drugs, indigenous populations, prisoners and other people living in closed settings) and women, adolescent girls, and marginalized communities—the Declaration fails to respond with urgency to the growing crisis of criminalization, discrimination, human rights violations, and inequalities that are increasing vulnerabilities and barriers to HIV services. And instead of a call to reconstruct effective HIV prevention and treatment programs during a time of catastrophic setback, the declaration points the finger at countries most affected by massive, unplanned HIV funding cuts to do more, without demanding similar accountability and corrective action from the wealthiest countries.



# The People's Declaration

**We call for the People's Declaration on HIV and AIDS ("the People's Declaration"), which describes what the political declaration should contain if it were to make meaningful impact at a moment of crisis in the global HIV response<sup>1</sup>:**

Despite the existence today of evidence-based, high impact biomedical, structural and human rights interventions, which, if deployed equitably and at scale, could defeat HIV as a public health threat, we have instead failed to respond to the AIDS pandemic with the full power of those tools;

Instead, after 45 years, we have now reached a moment of precarious backsliding, triggered by unprecedented funding cuts from the US and other bilateral donors. At the same time, rising attacks on criminalized and oppressed groups such as LGBTQI+ people, women, sex workers, people who use drugs, and a rejection of scientific evidence, are eroding already inadequate access to HIV services, increasing human rights violations, and fueling further inequities;

**We call on all countries, in partnership with communities and civil society, to meet this moment with the following concrete actions:**

1

Implement and urgently scale up access to the latest evidence-based biomedical and structural interventions in our countries, so that the advances of science and policy translate rapidly into equitable access for all populations in need, regardless of where they live or their ability to pay, gender, sexual orientation, age, refugee or immigration status. Achieve the 95% - 95% - 95% targets, not only nationally but for all sub-populations, ages, genders, and all sub-national geographies and leave no one behind.

## The People's Declaration on HIV and AIDS

2

Respect, protect, and fulfill the human rights, particularly the right to health, of all people living with HIV and people at risk of HIV acquisition and prioritize their rights ahead of private interests and short-term political gains. Institutionalize their leadership in HIV governance and decision-making at every level. End all forms of criminalization of people living with HIV and HIV transmission, exposure, and non-disclosure. End the criminalization of those most affected by HIV, including gay men and other men who have sex with men, sex workers, people who use drugs, and trans people, recognizing that punitive legal environments drive people away from prevention and treatment services. Oppose the summary deportation of migrant workers with HIV. Confront and resist the coordinated and well-funded anti-rights movement, including its attacks on gender equality, sexual and reproductive rights, and the rights of key populations, which advances through disinformation, restrictive legislation, and the defunding of services, and which fuels stigma, discrimination, and new HIV infections.

3

Advance gender equality and realize the human rights of all women and girls, including women living with HIV, adolescent girls and young women, sex workers, women who use drugs, and trans and gender-diverse people. Recognize women as leaders in all aspects of the HIV response and promote their voice, autonomy, agency, and leadership. Implement gender-transformative strategies that address the harmful gender norms, practices, and power imbalances that increase women and girls' vulnerability, including by ending child, early and forced marriage and female genital mutilation, and protecting bodily autonomy. Expand economic empowerment and social protection to reduce their vulnerability to HIV, increase access to woman-controlled HIV prevention, and support the collection and use of gender-disaggregated data, community-led research and community-led monitoring to identify and address stigma, discrimination, reproductive coercion, and other barriers to care.

4

Ensure that all people living with, at risk of and affected by HIV have access to people-centered services that address HIV, noncommunicable diseases, mental health conditions and other health needs across the life course in an integrated manner. As populations age and multimorbidity increases, strengthen primary health care and community-led responses to deliver coordinated care.

## The People's Declaration on HIV and AIDS

5

End Advanced HIV Disease (AHD) and eliminate preventable AIDS deaths; ensuring all people with HIV, including those who have fallen out of care or have been denied services, have access to the full WHO-recommended package of advanced HIV disease management. No person should die of AIDS-related illness when the tools to prevent that death exist.

6

Support and deploy independent community-led monitoring programs at scale, in all countries, to determine the extent of the damage from funding cuts, the true impact of integration of differentiated HIV services into general health systems, and to catalyze advocacy to demand corrective action.

7

End perinatal HIV infection by 2030 by accelerating provision of comprehensive, quality HIV prevention and treatment services to pregnant and breastfeeding women and HIV-exposed and HIV-positive infants. Rebuild the network of peers who are trained and remunerated to provide pregnant and breastfeeding women and their families with community health services and support to ensure quality care, delivered with dignity. Ensure all perinatal prevention programs uphold dignity, bodily autonomy, informed consent, confidentiality, non-discrimination, access to justice, and support women and adolescent girls living with HIV to make free and informed decisions regarding pregnancy, childbirth and infant feeding. Eliminate HIV-related obstetric violence and discrimination in health settings, including forced and coercive sterilization, abortion, or pregnancy and other violations of reproductive autonomy; breaches of confidentiality; mistreatment and abuse during pregnancy, childbirth and the postnatal period; and coercion regarding infant-feeding decisions.

8

Provide quality comprehensive sexuality education for adolescents and young people, in and out of school, that is age appropriate, evidence and skills-based, actively changes harmful gender norms, roles and power imbalances to create gender equality, respects human rights, addresses the realities of their lives, and empowers adolescents and young people to exercise their sexual and reproductive rights and access sexual and reproductive health and HIV services.

## The People's Declaration on HIV and AIDS

9

Achieve reproductive justice and realize the sexual and reproductive health and rights for all people living with or at risk of HIV, including their rights to bodily autonomy to decide freely and responsibly on matters relating to their sexuality and reproductive health, and empowerment, throughout the life cycle, without coercion, discrimination and violence.

10

Prevent, respond to, and eliminate sexual and gender-based violence, through rights-based approaches that are fully integrated into HIV prevention, treatment and care programs, place survivors at the center, and ensure access to justice.

11

Ensure access to treatment and prevention for all people in prisons and in other closed settings, as well as continuity of care for people recently released from detention. Integrate prison health into national HIV responses, recognizing access to comprehensive HIV care in prison is a human right, as well as an integral component of public health.

12

Invest in rights-based and community-led digital health systems to expand access to HIV prevention, testing, treatment, care, and support, while protecting privacy, confidentiality, informed consent, and safety from digital surveillance, outing, harassment, or misuse of confidential data, or the dissemination of mis- and disinformation, including HIV denialism and anti-rights propaganda.

13

Provide and sustain adequate funding for the global HIV response, recognizing that the catastrophic withdrawal of U.S. funding, exacerbated by cuts to HIV and Official Development Assistance (ODA) from other donors, has created an emergency that demands immediate corrective action. Deliver a fair share of global HIV financing from high-income countries, and reject any conditionalities on HIV funding, such as those that discriminate against key populations or undermine human rights and asymmetrical bilateral agreements on HIV that use health funding to coerce countries. Ensure sustained and long-term financing of local, feminist, LGBTQI+, youth- women- and community-led responses and services for people living with, at risk of, and affected by HIV, recognizing that they are frontline responders, including in humanitarian and emergency preparedness and response and conflict and crisis situations.

**14**

Adopt, use, and protect the public health flexibilities available under the World Trade Organization (WTO) TRIPS Agreement as clarified by the Doha Declaration on the TRIPS Agreement and Public Health of 2001. Raise the bar for patentability (excluding new uses, new forms, and new formulations of existing health technologies) and set up easy-to-use compulsory and government use licensing procedures with wide grounds for the issuing of such licenses. Adopt the pharmaceutical transition period in all least developed countries until 2033 or until they are no longer a least developed country in accordance with the extension period allowed under WTO rules. Refrain from any and all efforts in trade agreements or otherwise to impose "TRIPS-plus" measures or to retaliate against other countries for using TRIPS flexibilities.

**15**

Increase investments in research and development for long-acting HIV treatment and prevention commodities, HIV vaccines, and a cure, including through public and blended financing, ensuring guarantees for equitable access at the outset, binding data-sharing norms that include open access to trial and other data, and building and strengthening HIV research capacity in high-burden countries.

**16**

Ensure by 2030 that 90% of people in need of prevention have access to evidence-based methods, including pre-exposure prophylaxis (PrEP) for HIV for 20 million people, as well as post-exposure prophylaxis, condoms and lubricants, and harm reduction commodities and services so that supply and access keep pace with needs across communities and geographies to ensure that all people who need them can access and use them. Ensure volumes of affordable, generic long-acting PrEP keep pace with global demand in all geographies.

## The People's Declaration on HIV and AIDS

17

Challenge, dismantle, and transform colonial legacies and patriarchal power structures that perpetuate and sustain gender inequality, drive HIV vulnerability, fuel the HIV epidemic, and reinforce stigma and discrimination. These intersecting systems continue to dehumanise people living with HIV, undermine their rights, dignity, and agency, and create significant barriers to equitable access to the services, treatment, care, and support necessary for healthy, dignified, and self-determined lives.

18

Strengthen multilateral cooperation, including by strengthening UNAIDS and fully replenishing the Global Fund to Fight AIDS, Tuberculosis and Malaria and Unitaid. Recommit to the Sustainable Development Goals (SDGs) and recognize that their full implementation is necessary for development justice and achieving our collective goal of ending AIDS by 2030.
